Landscaping

Nothing to report other than to remind the Board that Brightview needs to begin to weed and water the newly planted section on WMR throughout the growing season. Several of the plantings have not survived and it is my understanding that Beebe will replace any plants that have died. I am not sure if this has been scheduled but perhaps Chris can so advise. Peter DeBisschop has once again stepped forward and has been watering and weeding all summer long - something that we are paying a contractor to do. Fortunately, 3 homeowners have stepped forward and are helping Peter but we are paying a landscaping company to do this and it should not be left to homeowners to assume this responsibility. This community owes Peter a debt of gratitude and I ask that he be recognized during the Board's regular meeting.

The entrance island on WMR also needs weeding pruning and because Brightview has failed to do this, we have sacrificed a second flush of bloom on the nepeta (the purple flowers).
