Community Garden:

Nothing to report this month.

Communications:

Google has implemented restrictions on mass emails. We have over four hundred addresses in our system. A number of our messages have bounced as undeliverable. We tried smaller groupings, but those failed as well.

We have worked with our website provider. He has enabled us to use the website as an email system, with a slight revision for incoming or reply messages. The website provider will host the email system for an additional \$25.00 per year.

We will announce the changes in an email, but the change will be nearly invisible to recipients. The new system will encompass the general email system and the legal notices system. We will work with Elite on the transition of the legal notices system.

Documents:

The final boundaries presentation was held on June 6th. Six people attended. Four votes were collected.
