The biggest change will be that directors and committee chairs who want to send out notices, agendas, etc. will have to work within the confines of Elite's operating hours.

Why the change:

- 1. We can no longer get volunteers to run the existing system.
- 2. More and more, residents are replying to notices rather than contacting Elite for property management issues.
- 3. Many of the messages going out via notices originate from Elite in the first place.

Meeting House:(Roland B.)

The Meeting House Committee met this past Tuesday. Here are notes from that meeting.

- We filled in the Before/After Volunteer calendar for the remainder of the year.
- Roland noted that the water heater has recently been replaced and an annual maintenance contract is now in place.
- Roland informed the committee that ADT has been approved to replace the security system. Installation dates still pending.
- MH questions/issues raised:
 - o The bathroom and kitchen should be repainted. Peter said he has the paint already.
 - o Should the ductwork be cleaned. It has probably never been done. Cost could be extensive.
 - Roland will ask Chris to have it inspected first.
 - O Gutters (upper and lower) should be checked and cleaned if necessary.
 - Roland will ask Chris to have this done.
 - Consider power washing the outside of the MH.
 - Roland will ask Chris to have this checked out and, if necessary, added to the spring power washing schedule.

- o Depending on the MH usage over the next couple of months, consider having the carpet deep cleaned in the fall.
- A discussion ensued over when people don't follow the rules. For example, the most recent rental didn't place the parking cones around the circle to prevent parking (no one did park there).
 - o Roland will add a note in bold red on the rental document that reminds renters of their responsibilities and the ensuing fines if not in compliance.
- Question was asked about MH usage going forward for internal WW meetings. Because of pandemic fears and caution that is still around, some are reluctant to meet in person.
 - We are considering wi-fi for the MH. Peter did note that this is more complicated than it sounds, given the need for both video and audio coverage.
- Roland also noted that, with all of his other Council and Conservancy responsibilities, he would like to pass on the leadership of the Meeting House Rental Committee to someone else. If any of you are willing to take this on, it would be a great help. It is not very time consuming. Templates already exist for the various communications to the renters, as well as a simple "to do" checklist for each renter.
