- Meeting called to order at 7:00 pm by Director Lattimer with congratulations to Chris Kohnle and his family on their new addition.
- The meeting minutes of September 28, 2016 were reviewed and approved with one minor change. The change was to change the word "with" to "within" in the second paragraph from the bottom on page 1. Director Tracy made the motion which was seconded by Director Towers. All Directors approved the minutes except for Director Onessimo who abstained.
- Financial report given by Director Tracy. All councils were in the black. Current net income year to date (9/30/2016) is \$39,290.76. Water bills expected in September were received in October and amounted to approximately \$55,000.
- Manager's Report:
 - o The water bills that came in October should be at or under budget for the year
 - Boundary Review: Maps and documents sent to Peter DeBisschop. Peter is moving forward with documents. The next steps will be to present the boundaries to the community, the community will then have time to look at with their councils and then the community will vote to approve the documents. An affirmative vote is needed of 2/3rds of the community.
 - The Conservancy budget workshop will be at 7pm on November 22nd. All other council workshops have been scheduled.
 - O Pool Cameras: Elite is working with Jim Nasuta and Horizon Technologies. There will be 4 cameras. The cameras will provide for zero blind spots. The cost is approximately \$3,300 plus the services of an electrician and the purchase of a small heater. 3 of the cameras will be on the Cupula and 1 will be on the corner of the cabana.
