Duplex Council Meeting February 23, 2018 2 Dunbar Drive

Attending: 2 Directors and 2 Residents; Total: 4 from DC

The meeting was called to order at 7:00 p.m.

1. Landscaping Snow Removal Issues

So far there have been no issues or concerns and the residents in attendance felt the snow removal has been going well.

2. Townhome Proposal to change the cost ratio for landscaping and snow removal

Kathleen Reported: After several back and forth negotiations, the TH Council agreed to a 60% - 40% split between the Councils. We are currently splitting it 52%-48% which is not a fair allocation based on the disparity in the number of driveways and the acreage of land. They proposed a 62%- 38% base on the numbers from Russo. That would mean a \$20.00 increase in HOA fees for all home owners. We negotiated that we would do a 60-40 split meaning a \$17.00 increase which will be applied in January 2019. Our HOA fees could increase further base on how our budget fairs this year, but we are not anticipating an additional increase beyond the \$17.00 at this time.

3. There are still 25 DC residents who have not voted for the boundaries yet. We did decrease that by 3 from last month. Every vote counts!

Also, Diane Corcoran has had an increase in her responsibilities at work and has asked to be replaced. She doesn't want to miss council meetings because she is tied up at work. If you have a slight interest, please contact Kathleen Tracy and discuss how you might serve our Council as a Director.

5. Standards Committee Report: Theda

- a) Theda wanted to remind residents that the spring is coming and if you intend to do any work on you home, you must FIRST submit and AAI form to Elite so you will not be fined. Right now the fine is \$100 for not submitting a form and another \$75 for starting the work before you have approval. Both fines will apply if start work without an AAI. At the February 28 board meeting, they are proposing that these fines increase (double). If you have concerns about that, you should make them known at the meeting (7PM).
