# THE BEAR ESSENTIALS

Have you heard the rumor that we're going to change the name of Walden Woods to Wild Kingdom? It may be justified considering the influx of wild animals from the woods into our "civilized" community. As some of you know, the latest furry four-legger to join us is a black bear. Instead of the monstrous, snarling, flesh-eating image portrayed by Hollywood, however, our bear is apparently more of the small, timid variety with a penchant for birdseed. Some witnesses even say the bear growls with a lisp and has a limp paw.

In any event, we do have a black bear in our midst. He (she or it) joins the previous invasion of fox and coyotes reported in previous years. Before the conversion of the animal's habitat into what is now known as Country Walk, the only "wildlife" seen around here were a few chipmunks and an occasional turtle. Let's hope the remaining trees are enough to keep the tigers in place.

For those of you who may be somewhat concerned about a face to face confrontation with the bear, here are a few things you should know, compliments of the state's Department of Environmental Protection:

If you see a bear while hiking, make your presence known by making noise and waving your arms. And if you happen to surprise a bear nearby, walk away slowly.

There is a misconception that black bears are vicious animals and that they are likely to attack people in defense of cubs. Black bear researchers often capture screaming cubs in the presence of mothers with no attacks.

If you do have a dog, however, keep it on a leash and under control.

Bears are attracted to garbage, pet food, compost piles, fruit trees and bird feeders around houses. You can help discourage the bear from visiting your area by temporarily discontinuing the feeding of birds, placing your garbage cans inside a garage or shed, adding ammonia to your trash, cleaning and storing grills after use, not including meat or sweets to your compost pile, and not leaving pet food outside overnight. And, as if you need this advice, DON'T intentionally feed bears. Bears that become accustomed to finding food near a home may become "problem" bears.

Most black bears become active a half-hour before sunrise, take a nap or two during the day, and bed down for the night an hour or two after sunset. However, some bears are active at night to avoid people or other bears.

In summary, if you see a black bear, don't try to pet him. But don't panic either; he doesn't want any part of you any more than you do him. If you see any sign of aggressiveness, report the incident to the DEP's Animal Control Center.

### WALDEN WOODS ENVIRONMENTAL UPDATE

Water quality in our two ponds remains the primary concern of the Environmental Committee. Three Vortechnics units have been installed to treat storm drainage into Big Walden Pond from Walden Woods. These units are currently treating all the drainage from Walden Meadow Road and will eventually remove pollutants that would otherwise drain into the pond from Country Walk as well. They will not be fully effective, however, until the finish grade of asphalt has been installed on all the roads in Country Walk.

There is also untreated drainage coming from the adjacent Unisource property that enters through an intermittent stream. The Committee continues its efforts to get our industrial neighbors and the Town to make improvements to this drainage, but no significant progress has been made to date. Our consulting engineers advise us that no other measures can be considered to improve the water quality in Big Walden Pond until the Vortechnics units are all functioning and the Unisource drainage improvements are complete.



The Committee is currently considering experimenting with an algae treatment of Little Walden Pond (the pond near the swimming pool). Under consideration are possible chemical or natural treatments to kill and prevent algae growth as well as possible skimming procedures. The Committee has recommended the discouragement of grass around the pool and the planting of more bushes to improve the water quality of surface drainage into the Pond. The fountain, while aesthetically pleasing, is probably having no significant impact on water quality.

Also scheduled for this month is the forestation of the westerly 100 feet of the flower meadow between the existing woods and Marshall Phelps Road. The additional trees will help to protect our environment in general and improve the water quality of one of our vernal pools.

Funding for the Vortechnics units and the forestation is being provided by the Country Walk developers. Funding for the industrial drainage improvements is expected to be provided by Unisource. If our Conservancy Board approves improvements for Little Walden Pond, funding will be needed from the Walden Woods Conservancy.

### **UPDATE ON AMENTIES**

**Meeting House** – Ta dah! The vinyl siding project is complete and new outside lights installed. Only some minor trim painting remains to be done.

**Tennis Courts** – A wind shield has been installed on the lower tennis court. The installation of a backboard to allow individual practice on the court was canceled after the Conservancy Board determined the cost to be prohibitive for the likely limited use.

**Overheard at the pool:** "I've reached the age where Happy Hour is a nap."

**Swimming Pool** – The cigarette receptacle and bike rack have been installed outside the pool area and the squirrel-damaged vents in the cabana cupola have been replaced with vinyl. For the month of July, 437 homeowners and their 253 guests visited the pool. With four bad-weather days, that's an average of 26 visitors per day compared to June's total of 21 per day.

THE POOL WILL REMAIN OPEN THIS YEAR THROUGH SEPTEMBER 16TH.
