# 2011 – A YEAR OF CHANGE IN WALDEN WOODS???

Com-mu ni ty (ka myoo' na  $t\bar{e}$ ) n.: fellowship 2. a group of people living together as a smaller social unit within a larger one and having interests, work, etc. in common (e.g., Walden Woods).

There is the potential for some changes to the way our community is run next year that could affect all of us. Some of the volunteers who provide the rest of us with services that make living in Walden Woods a lot more enjoyable will no longer be available to provide those services. Although there are several reasons for their unavailability, the simple, blanket explanation is that after years of service, they're "burned out". And it's not fair to deny them the rest they seek.

Now we desperately need replacements. Other homeowners are needed to take their turn in making the on-going small sacrifices needed to serve the community. For those of you who, for whatever reason, have ignored previous appeals for help, now is a very good time to reconsider. For those of you who have ignored previous publications and available website information that describes the various opportunities to serve, now is the time to take your head out of the sand. For those of you who are new to Walden Woods, don't let your lack of familiarity with the community get in the way. Learn by doing, get involved.

The enclosed insert provides a description of the responsibilities and needs of each committee, whom to contact for more information and the potential impact to the community if the needs are not met.

#### NO MAINTENANCE BUILDING

The homeowners of Walden Woods have spoken. CWD, the Country Walk developer, will <u>not</u> be required to build us a Maintenance Building as stipulated in their original development plans approved by the Town of Windsor.

Each of our 240 homeowners had an opportunity to express their opinion as to whether or not they wanted the additional amenity and to date 168 have signed the amendment to repeal the developer's obligation. Only 161 (67%) signatures were required to pass the amendment. In the end, most of

us expressed concern over whether the amenity was needed and



whether its potential benefits justified the additional maintenance expense and potential security issues.

The Board of Directors has notified CWD of our decision and they will now submit the necessary paperwork to the Town of Windsor to remove the Maintenance Building from the site plan.

#### **2011 BUDGET**

The Conservancy Board of Directors has approved the 2011 budget which will now be voted on by homeowners at the December 15<sup>th</sup> Annual Homeowners Meeting.

#### WALDEN POND INS AND OUTS

Out: Last February, a hired trapper completed a three month effort to rid our community of the beavers that were destroying so many trees around the pond. Only three beavers were caught and at the time, no one knew how many were left. As it turns out,



apparently <u>all</u> were caught – or the word spread among the survivors that it was time to leave. No more trees have been lost to the eager rodents.

In: Two years ago, we stocked Little Walden Pond with carp in an effort to rid the pond of the duck weed that turns the pond an ugly green. It turned out that the rumored fondness the fish had for the weed as a gourmet treat was true. The green muck has, for the most part, disappeared. Based on this success story, the Board of Directors has approved the stocking of carp into Big Walden Pond next spring. A fish barrier will be installed in the spillway to prevent the little gourmands from escaping.

#### POND PLATFORM SINKING?



Despite a homeowner survey that indicated the majority of us would like to have an observation deck atop the concrete dam foundation on Walden Pond to remedy an eyesore and help preserve our safety, it may not happen. And there are two culprits to blame: Pride and Prudence. Eli Pechtold, the Country Walk developer who offered to reimburse us up to \$30,000 for the project, refuses to sign any legal document that would bind him to his verbal offer. Citing a history of fulfilled commitments initiated on only his word, he apparently views our need for anything more than a handshake as a personal offense. To protect the community's interest in

avoiding a potential major unbudgeted expense, however, our Board of Directors voted (with some reluctance) not to proceed without a signed agreement.

Mr. Pechtold's counter offer to reimburse us on a piece-meal basis according to a schedule of planning, town approval and construction related expenses is being considered, but there is still reluctance to accept that offer because of the lack of a guarantee the reimbursement would continue once the project gets started. And it looks like the cost of the project may exceed the promised \$30,000 reimbursement. Because of the potential benefits to both the developer and the community, however, negotiations are continuing.

You know you're getting older when, on seeing an enormous embankment of all hued leaves, twelve feet in length, mounded up along our roads, you wonder if kids ever jump into them anymore, scattering their perfect discipline across the still green berns. You know you're not THAT old when you wonder what it

would feel like to do the same. And you feel seriously tempted to do it just one more time.

Is it just me or did the colors come and go rather quickly this year? I thought they did. And all of us who have lived here for awhile know exactly how and when our annual tide of autumn glory flows and ebbs. Just as soon as the mature maples along the northeast side of Walden Meadow Road begin to flag, announcing the coming season with a single branch or two of vivid red and yellow against the prevailing green in late September, it seems that Halloween comes and it's mostly over. Then, even the two cherry red lollipops, the twin burning bushes that adorn the base of the lawn in front of the meeting house, are forced to give up their crimson shout.

Early on, when most of the trees are still in their glory, the leaves that are fallen are remarkable. If you pause to pick one up, you will see colors and patterns that are quite wonderful. I've counted at least twelve different species of oak leaves in our environs, some intricately lobed, some more broadly formed, each individually contoured, no two alike. formed mounded ramparts of leaves now gone, an unruffled pristine blanket of white will lure with its perfection and I'll again feel temptation. Anyone for snow angels?

#### **COUNTRY WALK STATUS UPDATE**

As previously reported, the Conservancy will assume ownership of all un-developed property in Country Walk, including any un-finished/un-declared homes, when the developer's rights expire in February. Any <u>finished</u> homes not yet sold will be owned by the developer and he will assume the same responsibility as any other owner including the payment of association fees.

As of November 15th, with three months to go, all but six of the 180 planned units have been completed (albeit not all with landscaping and interior fixtures). Of the 174 units available, 84 have been sold and are now occupied. Eight others are scheduled for closings. The bottom line is that 88 units remain unsold, including those still under construction.

#### "MOUNTAIN" COMING DOWN

After four years, the "mountain" that's almost become a landmark near the Lockview traffic circle,

is finally being removed. Created from excavations during the initial stages of Country Walk's development, the large pile of dirt is being trucked off for use at a construction site in Bloomfield. Using it for
