TRANSFUSION NEEDED

In keeping with the spirit of Halloween, Walden Woods is looking for new blood.

It's been more than a year since homeowners took control of the association from the developer, and a few of the small group of volunteers who have carried us so nicely through the transition period, are getting a bit weary of carrying the load. Some are expected to "retire" at the end of the year and they <u>must</u> be replaced in order for our community to maintain the same level of control and benefits that it currently enjoys. This need for "new blood", however, poses a problem.

Who's going to fill the vacancies?

Of the 156 households in Walden Woods, only 25 have at least one member currently serving as a volunteer. Of the 260 adult residents, only 34 have volunteered their time and effort to make sure their community is in a condition to be enjoyed by their neighbors.

There are many opportunities for homeowners to get involved. We know we are going to need people to replace **Directors on the various Council Boards**. There are currently three Council Boards with a total of six Directors (Village =3, Woodmoor = 2, and Ridge = 1). Each Council Director elected also serves on the Conservancy Board of Directors. Elections of new Directors will take place this December at the annual meeting of homeowners and **there will be vacancies**. COSTS AND BENEFITS OF LIVING IN THE VILLAGE COUNCIL

Editor's Note: This is the second of three articles written by Conservancy Board Director Warren Johnson to help explain how our monthly association fee is used. The first article, printed in the July issue of this newsletter, explained how \$60 of the monthly fee we <u>all</u> pay is used for common expenses identified in the <u>Conservancy</u> Budget. This article pertains to the additional \$210 currently paid by all <u>Village</u> Council homeowners for expenses applicable only to that council's budget.

The Village Council within Walden Woods is comprised of the 24 condo-styled homes clustered around the Meeting House and 48 homes spread out on the Knoll. Unlike most condominiums, Village

homeowners own the outside surfaces of their homes and must maintain those outside surfaces at their own expense. They also must maintain the "limited common areas", the small fenced-in portions of the common areas adjacent to their homes, which they do not own but have the exclusive right to use.

In addition to the above expenses and the monthly \$60

fee for Conservancy-related expenses, each Village homeowner pays \$210 to cover budgeted expenses for services that apply exclusively to the Village Council: • Maintenance of the lawns and plantings in the land around the Village homes • Maintenance of the private streets in the Village Council • Snow plowing and snow shoveling of the private streets and of all driveways and walkways in the Village Council, including those homes on the Village side of public streets (Pierce Blvd., Mercer Lane and Hawthorne Lane) • Maintenance (and replacement) of fencing that delineates the limited common areas from the common areas in the Village Council • Maintenance of the stone and vinyl fencing at street corners in the Village Council • Maintenance of the stone mail box structures in the Village Council • Maintenance of the signage and street lighting in the Village Council and • Lawn irrigation in the Village Council.

Here's a rough allocation of the monthly \$210 common charge budgeted in 2005 for the Village Council:

- \$ 28.27 administration/management expenses
- \$ 5.31 meeting house expenses *
- \$ 7.38 electricity and water expenses



- \$ 7.81 contract services to maintain the Village irrigation system
- \$ 71.20 contract services to maintain the Village landscaping
- \$ 11.57 contract services for mulching in the Village common areas
- \$ 6.48 contract services for fertilizing in the Village lawn areas
- \$ 38.42 contract services for snow plowing and shoveling
- \$ 3.56 miscellaneous common area expenses
- \$ 30.00 contribution to Village reserves for capital projects **

\$210.00 Total Monthly Expense Per Village Home

* In the 2005 budget, the Village Council and the 30 homes in the Ridge Council are paying all the expenses of the Meeting House. Starting with the 2006 budget, those expenses will be removed from the Village and Ridge Council budgets and transferred the to Conservancy budget for all homeowners to share.

** The Conservancy is presently conducting long range facility planning for appropriate reserve funding. In recent years, the expenditures for the replacement of wood fences with vinyl fences have exceeded \$20,000 per year which has used up most of the annual reserve contributions from Village homeowners. It is anticipated that this condition will continue for the next five years in order to complete the fence replacement which is likely to cost in excess of \$115,000. At the end of the five-year period, capital contribution levels will need to be maintained to replenish reserves for such future capital expenses as private road resurfacing and other infrastructure replacement costs.

Those of us who live here sometimes take things for granted, but life in the Village Council is pleasant. Homeowners can watch their lawns being cut, snow shoveled, grass watered, bushes maintained and other services performed for their benefit. We can also turn the key and travel without worrying about the many maintenance issues confronting other homeowners. Some of our neighbors volunteer a lot of their time and effort to help preserve and improve this life style at affordable costs and to them the <u>Walden Woods News</u> expresses the gratitude of the Village Council.
