## Walden Woods Neighborhood Tag Sale

Our annual neighborhood tag sale is scheduled for **Saturday, June 14, 2014 from 9AM - 3PM**. This is a terrific opportunity to clean-out unwanted items and earn some extra money. During last year's event, over 150 people visited our community to purchase goods. What can you sell? It's up to you! Where is it located? In your garage or driveway!

**Cost to participate: \$10 cash payable by June 8, 2014.** The fee covers expenses including advertising and signage for the event. Any money remaining after expenses are paid will be donated to the Windsor Social Services Council, which oversees the local Food & Fuel Banks.

**Advertising:** The tag sale committee will be handling the advertising for the event through local papers, the posting of fliers at local businesses, and signs throughout the neighborhood and entry points to our community.

## Community Documents

The Documents Committee is working on proposed revisions to the Declaration, the By-Laws, and the Rules. As the developer CWD has now completed the homes in Duplex and Townhome, the Declaration must be revised. All three documents need to be aligned with the last revision of the Common Interest Community Act. Current versions of the documents are located at <http://www.waldenwoodsct.com/regulationsdocument/>.

The revision process for the three documents has been underway for a year. It will take several more months to complete the proposed revisions. The Conservancy Board will then vote to accept, reject, or modify the proposed revisions. Once the proposed revisions pass a vote by the board, and after legal review, the three documents will be sent to unit owners for Notice and Comment. After the period required by the Declaration, the Declaration and the By-Laws will need an affirmative vote of 2/3rds of the unit owners to be adopted. Approval of the Rules requires a majority vote of the Board.

The Declaration and the By-Laws are on file with the Town of Windsor property records. The Rules are maintained and enforced by Elite. Elite also maintains any additions or changes to the Rules. All three documents are posted at [www.waldenwoodsct.com](http://www.waldenwoodsct.com).

## Additions, Alterations, or Improvements ("AAI")

When Walden Woods Unit Owners wish to make changes to their units or property they must submit the AAI Form to Elite. An AAI request is required by our Declaration, By-Laws, and Rules. AAI requests are managed by Elite, but reviewed by our Standards Committee.

There might be as many as eight steps required to complete an AAI, depending on the scope of the project. Some projects require building permits and Certificates of Insurance if a contractor is involved.
